
Adopted on JUN 26 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized and empowered to transfer the sum of \$8,100 in Fiscal Year 1975 Non-Personnel Expense funds from Department 05.60 (General Revenue Sharing Human Care Services Non-Personnel Expense Staff Costs) to Fiscal Year 1975 Department 05.61 (General Revenue Sharing Human Care Services Program Costs for funding community agency programs).

BE IT FURTHER RESOLVED, that the expenditures of \$8,100 from Department 05.61 (General Revenue Sharing Human Care Services Program Costs for funding community agency programs), \$6,207 in General Fund moneys budgeted currently in Department 05.61 and \$75,693 from Department 05.61 (General Revenue Sharing) are hereby authorized, solely and exclusively, to provide the necessary \$90,000 required for the Summer Recreational Support Program.


