

RESOLUTION NO. 213679

JUN 26 1975

WHEREAS, on June 12, 1975, pursuant to Resolution No. 213558, the City Council authorized the City Manager to execute 69 agreements with community and governmental agencies to carry out the 1975 Summer San Diego Recreational Support Program; and

WHEREAS, since June 12, 1975, the Human Resources Department has been advised that the following agencies, each numbered as they appeared in Resolution No. 213558, would not be signing the contracts as sponsors for said programs: No. 3, Barrio Station; No. 17, Carlsbad Youth Center; No. 26a, Inter-Tribal Council for Barona Indian Reservation; and No. 6, Black Federation; and

WHEREAS, new agencies have now become available to sponsor certain of said summer programs, those agencies being the San Diego State University Foundation; Gospel Tabernacle of Carlsbad, Inc.; Barona Tribal Council, Black Action Committee; and the Mental Society; and

WHEREAS, each such agency is willing to sponsor programs as numbered in Resolution No. 213558 as follows: San Diego State University Foundation to sponsor Barrio Station, Casa de la Raza, and Nosotros Car Club, No. 3; Gospel Tabernacle of Carlsbad, Inc., to sponsor the Carlsbad Youth Center, No. 17; Barona Tribal Council to sponsor Barona Indian Reservation,


