Edgar A. Pompey, Sr.	PARK & RECREATION DEPT. Park Division	\$630	Mr. Pompey is a Groundskeeper in the Park Division. Part of his functions includes periodic fertilization of annual plants in Balboa Park. This requires precision application of fertilizer, and was a difficult stoop-labor job. Mr. Pompey designed and made a special device which dispenses fertilizer accurately and easily at the base of these plants. A trial of his method showed a saving of \$6,300 per year in labor.
