

RESOLUTION No. 213705Adopted on JUL 2 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of CREELA BELLE DAVIS, a widow, executed in favor of The City of San Diego, bearing date of May 22, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto across a portion of Lot 19 of Caruthers Addition, according to Map thereof No. 27, filed in the Office of the Recorder of San Diego County, October 1, 1880, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SAN PASQUAL STREET.

That the expenditure of not to exceed \$1,000.00 from Gas Tax Fund 219 is hereby approved for the acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
