WILLIAMS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of May 15, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto across a portion of Lot 2 of Imperial - Euclid Center, Unit No. 1, according to Map thereof No. 5389 filed in the Office of the San Diego County Recorder May 15, 1964, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the expenditure of not to exceed \$2,500.00 from Gas Tax Fund 220 is hereby approved for the acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
