That the expenditure of not to exceed \$1,400.00 from Gas Tax Fund 220 is hereby approved for the acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
