

RESOLUTION No. 213710Adopted on JUL 2 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of OBIE R. BENNETT and TOMMIE G. BENNETT, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of April 30, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 42 of Horton's Purchase in the Ex-Mission Lands of San Diego, according to Map thereof No. 283, filed in the Office of San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the expenditure of not to exceed \$31,850 from Gas Tax Fund 220 is hereby authorized and approved for the acquisition of said real property and related expenses.

That the City Clerk is hereby authorized and directed to transmit said deed and a certified copy of this resolution to the Property Director for further handling.
