


RESOLUTION No. 213711Adopted on JUL 2 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of DONALD B. FAUCHER and MARILEE FAUCHER, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of May 8, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto across a portion of Lot 43 of the Highlands according to Map thereof No. 284 filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named VICKERS STREET.

That the City Clerk is hereby directed and authorized to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
