BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$10,000 from the General Purpose Revolving Fund 534 to Block Grant Housing Rehabilitation Fund 2912 for the purpose of providing personnel and nonpersonnel expenses incidental to planning a Housing Rehabilitation program under the Community Development Block Grant; such amount to be used from July 1, 1975, until release of Block Grant funds; and such amount to be reimbursed to Fund 534 from Block Grant when released.
