John C. McLean, Jr.	TRANSPORTATION DEPT. Airports Division	\$70	Mr. McLean is a Custodian/Guard at Montgomery Airport. He suggested that bicycles be used for some of the patrol activities instead of the pick-up trucks, both at Brown and Montgomery Fields. This has been done, and experience shows a saving of \$717 per year in the cost of the trucks.
John A. Clements	GENERAL SERVICES DEPT. Equipment Division	\$20	Equipment Mechanic John Clements suggested that two mounting bolts on Allison automatic transmissions be omitted when reassembling the transmissions. The bolts are not needed and the work is less difficult without them. It is estimated that this will save \$200 per year in maintenance.
Andrew Chavez	WATER UTILITIES DEPT.	\$20	Mr. Chavez, an Equipment Technician I, was concerned about the difficulty of lifting a heavy pump onto the bed of a truck. He suggested a place be provided for the pump under the body of the truck where it can quickly and easily placed or removed. This saves a little time, but primarily is a safer operation.
