

RESOLUTION NO. 213779

WHEREAS, the State and Local Fiscal Assistance Act of 1972, and the General Revenue Sharing program which it authorizes expires on December 31, 1976; and

WHEREAS, The City of San Diego will receive in excess of \$37 million from the Federal Government during the five year life of this domestic assistance program; and

WHEREAS, these millions of dollars have enabled The City of San Diego to inaugurate new programs, maintain routine services, and construct needed facilities without an increase in local taxes; and

WHEREAS, the state of the economy has greatly reduced local government revenue, forcing many cities to increase local taxes, contrary to national efforts to stimulate the economy by reducing federal taxes; and

WHEREAS, the early reenactment of the general revenue sharing program will reduce the possibility of local tax increases and insure the continuation of essential programs, services and construction; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City supports the reenactment of general revenue sharing in the 94th Congress on a multi-year funding basis which assures the City of receiving at least as much funding from this source as it has received in prior years, and provides the City

BE IT FURTHER RESOLVED, that the Legislative Representative is hereby directed to seek members of the Congressional delegation from San Diego to actively seek the initiation of such legislation.
