

RESOLUTION No. 213796Adopted on JUL 16 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of not to exceed \$2,582.00 from Fund 3713 is hereby authorized for the acquisition of the above described property.
