WHEREAS, the State of California is offering for sale to The City of San Diego excess state right-of-way, said land being Parcel "A" as shown on Map No. 907, filed July 21, 1972, in the office of the Recorder of San Diego County; and

WHEREAS, said property is located at the southeasterly corner of Dewey Street and Logan Avenue and is considered to be ideally situated for inclusion in the city's Bay Bridge Park; and

WHEREAS, the purchase of this property is recommended by both the Planning Department and the Park and Recreation Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the expenditure of \$13,700 from Capital Outlay Fund 245 for the acquisition of Parcel "A" as shown on Map No. 907, filed July 21, 1972 in the Office of the Recorder of San Diego County, be and the same is hereby authorized and approved.

2. That the acceptance by the City Manager of that Director's Deed, of the STATE OF CALIFORNIA, the form of which is on file in the office of the City Clerk as Document No. 752063, conveying to said city Parcel "A" as shown on Map No. 907, filed July 21, 1972, in the Office of the Recorder of San Diego County, be and the same is hereby approved.


