BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That the acceptance by the City Manager of that deed of BOARD OF ADMINISTRATION, THE SAN DIEGO CITY EMPLOYEES' RETIREMENT SYSTEM, executed in favor of The City of San Diego, bearing date of June 4, 1975, conveying to said City Lots "D" through "L" inclusive in Block 52 of Horton's Addition, as more particularly described in said deed, valued at \$500 or more as certified by the Property Director of said City, be and the same is hereby approved.

2. That the transfer of \$451,597.01 from the Capital Outlay Fund 245 to the Community Concourse Acquisition Fund 259 is hereby authorized and approved.

3. That the expenditure of not to exceed \$451,597.01 from the Community Concourse Acquisition Fund 259 is hereby authorized solely and exclusively to provide funds for the buy-back of the above described Centre City land.

4. That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
