

RESOLUTION NO. 213806

WHEREAS, the City has two lifeguard vehicles which have been surveyed and are no longer desirable for retention by the City; and

WHEREAS, the beaches from the border at Tijuana to Rosarito are now averaging one drowning call per week with ninety percent of all people involved in rescue and emergency medical incidents along these beaches being United States citizens; and

WHEREAS, the City of Tijuana, Rosarito Delegation, in an endeavor to establish a lifeguard service has offered to purchase said vehicles for two hundred dollars (\$200.00); and

WHEREAS, the paramount concern for protection of the lives and safety of the citizens of this City makes competition for the purchase of said vehicles unfeasible; and

WHEREAS, it is to the best advantage of the City to dispose of the aforementioned vehicles by selling the same to the City of Tijuana, Rosarito Delegation, for the price of two hundred dollars;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Purchasing Agent may sell two lifeguard vehicles which have been surveyed and are no longer desirable for retention by the City to the City of Tijuana, Rosarito Delegation, for the sum of two hundred dollars (\$200.00).
