


RESOLUTION No. 213813

That the President of the BOARD OF ADMINISTRATION of the SAN DIEGO CITY EMPLOYEES' RETIREMENT SYSTEM be, and he is hereby authorized and empowered to execute, for and on behalf of said Retirement System, an agreement with LITTLE, CHURCH & CHAPIN, INC., to provide actuarial services to the Retirement System for fiscal year 1975-76 with two one-year renewal periods extending to June 30, 1978, pursuant to the requirements of Section 24.0901 of the San Diego Municipal Code, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 752075.
