A RESOLUTION CONSENTING TO CONSOLIDATION OF PART OF SAN DIEGO COMMUNITY COLLEGE DISTRICT BOND ELECTION WITH CITY OF SAN DIEGO MUNICIPAL PRIMARY ELECTION TO BE HELD TUESDAY, SEPTEMBER 16, 1975.

WHEREAS, the San Diego Community College District, a substantial portion of which is located within the boundaries of the City of San Diego, has ordered a bond authorization election to be held on September 16, 1975, and the Board of Trustees of the San Diego Community College District has requested the approval of consent of the Council of The City of San Diego to the consolidation of that portion of the San Diego Community College District located within the boundaries of the City of San Diego with the City of San Diego Municipal Primary Election to be held on the same date; and

WHEREAS, it is desirable and in the public interest that the said elections be consolidated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to the provisions of Sections 1333 to 1336, inclusive, and 21752 of the Education Code and Division 12, Part 2, Chapter 4 (commencing at Section 23300) of the Elections Code, the City Council of The City of San Diego gives its approval of consent to the consolidation of that portion of the San Diego Community College District election

to be held within the boundaries of the City of San Diego with the City of San Diego's Municipal Primary Election to be held on Tuesday, September 16, 1975, and the County Superintendent of Schools of the County of San Diego is requested to order the consolidation of said elections.

BE IT FURTHER RESOLVED, that pursuant to Section 23307 of the Elections Code, the election shall be held within the City of San Diego in all respects as if there were only one election; only one form of ballot shall be used in said consolidated election; and the City Clerk of The City of San Diego shall canvass the returns of the election of this district as part of the canvass of returns of the City of San Diego's Municipal Primary Election.

BE IT FURTHER RESOLVED, that pursuant to Section 1335 of the Education Code within the territory affected by the order of consolidation, the election precincts, polling places, voting booths and polling hours shall, in every case, be the same and there shall be only one set of election officers in each of the precincts.
