A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO IN SUPPORT OF APPLICATION 53369 OF SAN DIEGO GAS & ELECTRIC COMPANY BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA SEEKING AUTHORITY TO CONSTRUCT AND OPERATE ENCINA UNIT 5.

JUL 17 1975

WHEREAS, the Public Utilities Commission of the State of California has reopened for hearings the application of San Diego Gas & Electric Company to construct and operate a steam fired generating unit known as Encina Unit 5; and

WHEREAS, the people of the City of San Diego have a vital interest in the continued reliable service of electric energy by San Diego Gas & Electric Company; and

WHEREAS, the City of San Diego concurs with San Diego Gas & Electric Company that an adequate reserve margin is essential to providing continuous electric service and that by 1979, without Encina 5, the utility's reserve margin will be so low that it will be virtually certain that the citizens of San Diego will not be able to enjoy continuous electric service; and

WHEREAS, the citizens of the City of San Diego concur and support San Diego Gas & Electric Company's desire to decrease this Country's dependence on fuel oil; and

WHEREAS, the City of San Diego concurs with San Diego Gas & Electric Company that installation of Encina 5 would result in a system-wide savings of nearly 600,000 barrels of fuel oil annually at an annual savings of approximately \$9,000,000;
