

RESOLUTION No. 213839Adopted on JUL 23 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

CROMWELL, executed in favor of The City of San Diego, bearing date of June 5, 1975, conveying to said City for park reserve purposes a portion of the Northeast Quarter of Pueblo Lot 1196 according to Map of the Pueblo Lots of San Diego made by James Pascoe in 1870, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of not to exceed \$5,365.00 from San Diego Park District No. 12F, Fund 3713, is hereby authorized solely and exclusively for the acquisition of the above stated property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
