

**RESOLUTION No. 213841**


Adopted on JUL 23 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer \$24,000 from General Purpose Revolving Fund 534 to Fund 2611, and that expenditure of said funds is hereby authorized, solely and exclusively, for the purpose of providing funds to sustain the Women's Detoxification Services of the Narcotics Prevention Project, a cooperative city project, for a three-month period; said funds to be reimbursed City from a grant of the California Council on Criminal Justice pursuant to Resolution No. 213610, adopted June 19, 1975.
