WHEREAS, the California Council on Criminal Justice has expressed the intent to award a grant to The City of San Diego, as a unit of local government for purposes of operating the San Diego Exemplary Work Program; and

WHEREAS, the San Diego Exemplary Work Program will provide employment and educational opportunities to certain youth living within the City of San Diego; and

WHEREAS, because of the nature of the San Diego Exemplary Work Program, the San Diego Unified School District is uniquely qualified to best implement and administer this grant program, and pursuant to the grant award, the City has been preparing to enter into a contract with the San Diego Unified School District to carry out the grant program under City supervision; and

WHEREAS, the San Diego Unified School District is ready, willing and able to be directly awarded said grant and to perform all the obligations imposed by said grant; and

WHEREAS, the California Council on Criminal Justice is now ready, willing and able to award said grant directly to the San Diego Unified School District upon condition that the City of San Diego waives all its rights to and obligations contained in the grant award; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said City hereby waives all rights and obligations with


