

RESOLUTION No. 213853Adopted on JUL 23 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Planning Commission is directed to conduct public hearings on possible modifications to the On-Premises Sign Ordinance and the advisability of deleting or revising the "S" Suffix zones and the CO, CN, SR, and M-IP sign regulations under a comprehensive City-wide sign review program.

2. The Planning Commission is directed to review the policy of imposing "S" Suffix zoning on any basis other than a comprehensive district or community approach.

BE IT FURTHER RESOLVED, that staff of the City of San Diego is directed to take no action to initiate abatement of signs within "S" Suffix commercial zones until the City Council has had an opportunity to consider the results of the public hearings to be held by the Planning Commission pursuant to this resolution.
