

RESOLUTION NO. 213871Adopted on JUL 30 1975

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Philip L. Rostadha	ENGINEERING & DEVELOPMENT	\$400	Mr. Rostadha, A Principal Engineering Aide, became concerned with the procedure that required Council approval for Notices of Completion for subdivision improvement work. He proposed that such approvals be made by the City Manager. This change has been approved by the City Council, and will save a great deal of time that was required by the former process. An initial award of \$400 has been approved by the Suggestion Awards Committee, and a record will show actual savings during the first year. An additional award may be justified then.
John E. Hoaglin	PROPERTY DEPARTMENT	\$220	Mr. Hoaglin is Building Maintenance Supervisor at San Diego Stadium. The ramps leading from the stadium to the field were covered with slip-proof rubber matting that required replacement several times each year. Mr. Hoaglin suggested that Astroturf be used as it will last about ten years, and is a better surface. It will save \$2,200 per year.
Rita M. Domler	WATER UTILITIES DEPARTMENT	\$100	Ms. Domler is Supervisor of Customer Records in the Customer Service Section. The established computerized system for tabulating Error Messages also made Work Assignment Orders. Over 21,500 of these were made each year although they were no longer needed. The programming was changed as Ms. Domler suggested, saving nearly \$1,000 per year in WAO forms, computer time, and clerical time.
