BE IT RESOLVED, by the Council of The City of San Diego as follows:

R76-0140

That the bids of 1. Consolidated Electrical Dist., 2. Graybar Electric Co. Inc., and 3. Pacific Union Metal Division, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of ELECTRICAL MAINTENANCE AND REPAIR MATERIALS, as may be required for a period of one (1) year beginning July 1, 1975 through June 30, 1976, per prices on file in the Purchasing Department, as follows:

1. Consolidated Electrical Dist., for Sections I, III and IV; terms 2% 30 days plus sales tax, with option to renew for one (1) additional year.
2. Graybar Electric Co. Inc., for Section II; terms 2% 10 days plus sales tax.
3. Pacific Union Metal Division, for Section V; terms net 30 days plus sales tax, with option to renew for one (1) additional year.
