

RESOLUTION No. 213882Adopted on JUL 30 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a master agreement with the STATE OF CALIFORNIA, acting by and through its DEPARTMENT OF TRANSPORTATION, to make available to City federal funds for implementing the 1973 Federal Highway Act, Title II, Section 203, Rail-Highway Section, under the terms and conditions set forth in the form of master agreement on file in the office of the City Clerk as Document No. 752180.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized, subject to the directions provided by the Progress Guide and General Plan and by the Capital Improvements Program, to make all applications, studies, reports, certifications and execute supplemental funding agreements as may be required under the master agreement above-referenced to obtain for City the federal funds available under the 1973 Federal Highway Act.
