BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF ONE HOUR, between the hours of 8:00 a.m. to 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:


Westerly side of LA JOLLA SHORES DRIVE, between El Paseo Grande and the Museum entrance, and the north side of EL PASEO GRANDE, between La Jolla Shores Drive and the west Museum entrance to the university parking lot.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that Resolution No. 208480, adopted July 26, 1973, be and the same is hereby rescinded.
