WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

Stanley A. Elmore	POLICE DEPARTMENT	\$650	A year ago Sgt. Elmore found a much less expensive type of Police badges. He was awarded \$350 at that time. Records show that \$11,200 was actually saved during the first year. This warrants an additional award of \$650.
Ray Haskell	GENERAL SERVICES DEPARTMENT	\$25	Carpenter Ray Haskell found another type of contact cement for use on library tables having linoleum tops and oak edging. This new material is less expensive, and easier to use. \$270 is saved in a year in the cost of cement and shop work.
Bernice F. Webber	AUDITOR & COMPTROLLER	\$25	Ms. Webber is an Intermediate Typist in the Auditor's office. She suggested changes in the method of processing telephone bills for payment. These were partially made for an estimated saving of \$247 per year in clerical time.
