RESOLUTION OF INTENTION NO. 213899

JUL 30 1975

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE COLIMA STREET BETWEEN CHELSEA AVENUE AND SEA ROSE PLACE; AN UNNAMED ALLEY SOUTH OF BLOCK 36, BETWEEN CALUMET AVENUE AND SEA ROSE PLACE, BIRD ROCK ADDITION, MAP NO. 1083 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of COLIMA STREET between Chelsea Avenue and Sea Rose Place; an unnamed ALLEY south of Block 36, between Calumet Avenue and Sea Rose Place, Bird Rock Addition, Map No. 1083, as more particularly shown on tentative Subdivision Map of Calumet Park, T.M. 73-185, on file in the office of the City Clerk as Document No. 752191.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 p.m., AUG 28 1975, in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper established and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street
