That the City Manager be and he is hereby authorized to retain a law firm of his choice to represent him in the matter of the contract between THE CITY OF SAN DIEGO and WIMMER, YAMADA, IWANAGA & ASSOCIATES in connection with the design of a Japanese Garden in Balboa Park, under the terms and conditions set forth in a letter dated July 28, 1975 from WHITE, PRICE, PETERSON & ROBINSON to the City Manager, a copy of which is filed in the office of the City Clerk as Document No. 752194.

BE IT FURTHER RESOLVED, that the Auditor & Comptroller be and he is hereby authorized to transfer within the 100 Fund the sum of \$5,000 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) to be used solely and exclusively for the above purpose.
