

RESOLUTION No. 213912

Adopted on JUL 31 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the appeals of Thomas H. Chadwick and Kenneth MacLeod, from the Street Superintendent's Assessment No. 3837, made to cover the costs and expenses of the work of paving and otherwise improving LOS ALTOS ROAD, between Collingwood Drive and Los Altos Way, under Resolution of Intention No. 205383, adopted April 18, 1972, as amended by Resolution No. 210399, adopted April 18, 1974, be and they are hereby overruled and denied and all other appeals, written or verbal, are hereby overruled and denied.

The Street Superintendent's Assessment No. 3837 is hereby confirmed and approved, and the Street Superintendent of said City is hereby authorized and directed to attach his warrant thereto and issue the same in the manner and form provided by law. Said warrant shall bear date of this order. The Street Superintendent of said City shall record in the office of said Street Superintendent said warrant, diagram and assessment. The City Clerk shall cause to be filed in the office of the County Recorder a copy of the assessment diagram and shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highway Code.
