That the bid of Consolidated Facility Services, Inc. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF FOURTEEN (14) OPEN SPACE PARK SITES within the Scripps Ranch Subdivision, for a period of twelve (12) months beginning August 1, 1975 through July 31, 1976, at a cost of \$2,895.00 per month, for a total cost of \$34,740.00; terms, 1% 10 days, with an option to renew the contract for an additional one (1) year period.
