WHEREAS, Resolution of Intention No. 213697, adopted
JUL 2 1975, declared this Council's intention to order
the confirmation of assessments for the San Diego Street Lighting
Maintenance District No. 1; and

WHEREAS, on the date, time and place set forth in said resolution
a public hearing was held with opportunity being given to those persons
desiring to protest; and

WHEREAS, pursuant to Chapter 6, Article V, Division 2, Sections
65.0201 through 65.0222 of the San Diego Municipal Code, the Council
has considered and reviewed the costs to be assessed for the supplying
of energy, maintenance and service for the ensuing year; and

WHEREAS, the proposed assessments for the said maintenance
district are on file in the office of the Street Superintendent and
have been made available for public inspection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. The Protests, if any, are overruled.
2. The assessments described in said Resolution of Intention
No. 213697 and on file in the office of the Street Super-
intendent of The City of San Diego for San Diego Street Lighting
Maintenance District No. 1 are hereby confirmed and approved as.


