RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
AWARDING A CONTRACT TO THE SAN DIEGO GAS & ELECTRIC
COMPANY FOR THE FURNISHING OF ELECTRICAL ENERGY AND
SWITCHING TO THE SAN DIEGO STREET LIGHTING MAINTENANCE
DISTRICT NO. 1 FOR A ONE-YEAR TIME PERIOD.

(SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1)

WHEREAS, Resolution of Intention No. 213697,
adopted JUL 2 1975, declared this Council's intention to
enter into a new contract with San Diego Gas & Electric Company
for a one-year time period to provide electrical energy and switching
to San Diego Street Lighting Maintenance District No. 1; and

WHEREAS, pursuant to Chapter 6, Article V, Division 2, Sections
65.0201 through 65.0222 of the San Diego Municipal Code a public
hearing was held in conjunction with said contract award; and

WHEREAS, this Council has considered all objections and protests
made at said public hearing and has overruled and otherwise disposed
of them; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


That the City Manager be and he is hereby authorized and
