
WHEREAS, by means of a series of oral and graphic presentations to the Balboa Park Committee and the Park and Recreation Board, the OLD GLOBE THEATRE INC. BOARD OF DIRECTORS has proposed to construct an 800 seat theatre adjacent to the existing 420 seat Old Globe and the 245 seat Carter Theatres; and

WHEREAS, approximately 0.5 acres of city-owned land would be required in addition to the 1.2 acres presently used by the Old Globe complex; and

WHEREAS, at the June 2, 1975 meeting of the Public Facilities and Recreation Committee, it was determined that the request of the Old Globe Theatre to build a third theatre in Balboa Park be referred to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the concept of the construction of a third Old Globe Theatre in Balboa Park is hereby approved.
