

RESOLUTION NO. 213969

AUG 6 1975

WHEREAS, Resolution No. 195628, adopted December 26, 1968, effective February 1, 1969, established certain fees for police operated emergency ambulance service; and

WHEREAS, it is desirable to recover the cost of such emergency service to the public; and

WHEREAS, these fees no longer defray the expense of this service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is authorized and directed to charge and collect fees for such ambulance service according to the following schedule to be effective September 1, 1975.

1. For the transporting of any emergency patient when that patient requires the use of an ambulance, there shall be a charge of \$30.00.

2. There shall be a \$15.00 penalty assessed for the failure to pay any ambulance charge made pursuant to this schedule within sixty (60) days after the emergency service is rendered, except that such penalty may be waived by the City Treasurer or his representative where good cause for delay is shown.

3. All ambulance service charges shall be due and payable on the day the emergency service is rendered.
