


RESOLUTION No. 213982Adopted on AUG 6 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That FRANKLIN T. HAMILTON, Attorney at Law, be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the financing and acquisition of approximately 150 acres of undeveloped canyon land in the Del Cerro area for the proposed NAVAJO CANYON OPEN SPACE PARK ASSESSMENT DISTRICT (SAN DIEGO PARK DISTRICT NO. 11) under the provisions of the Municipal Improvement Act of 1913 and the San Diego Park District Procedural Ordinance of 1969, pursuant to the terms and conditions set forth in the letter dated March 28, 1975 on file in the office of the City Clerk as Document No. 752290.

In the event the proposed proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
