WHEREAS, the City Manager is the chief administrative officer of The City of San Diego and is responsible for supervising the administration of affairs of the City; and

WHEREAS, the position of City Manager was vacated upon the retirement of Kimball Moore; and

WHEREAS, as a result of said position vacation, it became necessary to appoint someone of recognized ability to perform the multivaried responsibilities and functions of City Manager until a new Manager was selected by Council; and

WHEREAS, the period of time for said interim appointment was exceptionally critical and vital in that the construction of the preliminary budget for the operation of the City for the forthcoming fiscal year was in process; and

WHEREAS, Assistant City Manager Ralph E. Graham was deemed by Council to be the person most qualified to serve as interim City Manager during this very critical period; and

WHEREAS, Mr. Graham was duly appointed to such position and served therein for the period December 14, 1974 through March 31, 1975; and

WHEREAS, his performance during this period was of such nature as to reflect significantly upon Mr. Graham's exceptional technical and professional ability; and

WHEREAS, such performance should not go unrecognized for the valuable service accorded the citizens of the community generally and the City government specifically; NOW, THEREFORE,


