

RESOLUTION NO. 213985

WHEREAS, Senate Bill No. 563 regulating tidelands heretofore granted the City would effectively transfer the control over policy decisions with respect to those tidelands to the State Lands Commission, resulting in the need for substantial numbers of additional staff in Sacramento and impose on the City a substantial economic burden; and

WHEREAS, Senate Bill No. 563 should be opposed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The City of San Diego is opposed to Senate Bill No. 563.

2. The Legislative Representative is hereby directed to express the opposition of the City to the enactment of the bill as reflected in that letter to the Chairman of the State Assembly Resources and Land Use Committee from the City Attorney dated July 22, 1975 and that memorandum to the Rules Committee of the City from the Legislative Representative dated July 10, 1975, on file in the office of the City Clerk as Documents No. 752296 and No. 752297, respectively.
