RESOLUTION OF INTENTION NO.

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF MURRAY CANYON ROAD, LYING OUTSIDE THE 70-FOOT-WIDE RE-ALIGNMENT IN PUEBLO LOT 1173 AND THE SOUTH HALF OF PUEBLO LOT 1182 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of MURRAY CANYON ROAD, lying outside the 70-foot-wide re-alignment in Pueblo Lot 1173 and the South Half of Pueblo Lot 1182 as more particularly shown on Map No. 12457-D, on file in the office of the City Clerk as Document No. 752343

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 p.m., SEP 18 1975 in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
