BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PHILLIP W. BROWN and HELEN L. BROWN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of June 30, 1975, conveying to said City a portion of Lots 29 and 30 in Block D of Alta Vista Suburb, according to Map thereof No. 1008 filed October 5, 1906, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of \$700 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
