

RESOLUTION No. 214001Adopted on AUG 13 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAN DIEGO COUNTY CHURCHES OF GOD, INC., a corporation, executed in favor of The City of San Diego, bearing date of May 13, 1975, conveying to said City certain easements for street and slope purposes affecting a portion of Lot 39 of the Ex-Mission Lands of San Diego commonly known as Horton's Purchase, according to Map thereof No. 283 filed March 9, 1878 in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of \$5,000 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
