BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with the SAN DIEGO COMMUNITY COLLEGE DISTRICT and the SAN DIEGO UNIFIED SCHOOL DISTRICT providing for the formation of a Joint Advisory Committee the purpose of which Committee shall be to formulate and communicate recommendations to the governing bodies of the City, the Community College District and the Unified School District with respect to (1) cooperative recreation programs acceptable to each; and (2) proposed expenditures for such capital improvements and other costs as may be appropriate to carry out the recommended program, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No.
