BE IT RESOLVED, by the Council of The City of San Diego as follows: *B76-198*

1. That the bid of \$24,940.00 by Select Electric, Inc., a corporation, for CONSTRUCTION OF SAFETY LIGHTING SYSTEMS AND TRAFFIC SIGNAL SERVICE MODIFICATIONS FOR WEST POINT LOMA BOULEVARD UNDERGROUND UTILITY DISTRICT (LOMA RIVIERA TO MIDWAY DRIVE), FOR EUCLID AVENUE UNDERGROUND UTILITY DISTRICT (CASTANA STREET TO FEDERAL BOULEVARD), AND COLLEGE AVENUE UNDERGROUND UTILITY DISTRICT (EL CAJON BOULEVARD TO MONTEZUMA ROAD) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 751420.
2. That the expenditure of \$33,800.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SAFETY LIGHTING SYSTEMS AND TRAFFIC SIGNAL SERVICE MODIFICATIONS FOR WEST POINT LOMA BOULEVARD UNDERGROUND UTILITY DISTRICT (LOMA RIVIERA TO MIDWAY DRIVE), FOR EUCLID AVENUE UNDERGROUND UTILITY DISTRICT (CASTANA STREET TO FEDERAL BOULEVARD), AND COLLEGE AVENUE UNDERGROUND UTILITY DISTRICT (EL CAJON BOULEVARD TO MONTEZUMA ROAD) in the City of San Diego, and related costs.
