BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$15,000 from the Transient Occupancy Tax Fund 223, American Tennis Association Tournament (52.30) to be used solely and exclusively for the above purpose.
