WHEREAS, MRS. CYNTHIA ERICKSON, dba Classic Limousine Service, has applied to the City Council for a Certificate of Public Convenience and Necessity to operate an automobile for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

- (a) There appears to be a demand for this type service.
- (b) The proposed auto-for-hire service will not conflict with existing taxicab, auto-for-hire, or bus service.
- (c) The applicant appears to be financially responsible. She presently owns and operates a successful foreign auto parts store. She has no prior experience operating an auto-for-hire or other type public transportation enterprise.
- (d) The vehicle to be used is a black 1970 Cadillac Fleetwood Limousine. The vehicle will be available for inspection upon approval of this application.
- (e) This service will not significantly add to traffic congestion or parking.
- (f) This additional service within the City will not result in a greater hazard to the public.
- (g) Mrs. Erickson's personal and business references have been checked satisfactorily.


