

RESOLUTION OF INTENTION NO. 214039

AUG 20 1975

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE ANY PORTION OF A PUBLIC ROAD, KNOWN AS ROAD SURVEY 294, THAT LIES WITHIN THE BOUNDARIES OF THE PROPOSED SUBDIVISION "BEYER BOULEVARD SUBDIVISION, T.M. 74-84" AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of such rights as may exist in a portion of the public road known as Road Survey 294 within a portion of the Southwest Quarter of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian, as more particularly shown on tentative Subdivision Map of Beyer Boulevard Subdivision, T.M. 74-84, on file in the office of the City Clerk as Document No. 752444.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 a.m., SEP 18 1975, in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


