

RESOLUTION No. 214040Adopted on AUG 20 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the delivery of that instrument entitled Offer to Dedicate, executed by RANCHO BERNARDO, INC., a California corporation, in favor of The City of San Diego, bearing date of June 11, 1975, offering to dedicate to public use for street purposes a portion of Rancho San Bernardo, according to the Map filed in the Office of the County Recorder of San Diego County, in Book 2, Page 462 through 469 of Patents, as more particularly described in said instrument, be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance of delivery, the City does not dedicate to public use for street purposes the portions of land described in said instrument but reserves the right to accept said offer to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said offer to dedicate in the office of the Recorder of San Diego County.
