

RESOLUTION No. 214046

Adopted on AUG 20 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 85.04 of the San Diego Municipal Code, the USE of the following-described streets be, and it is hereby PROHIBITED AT ALL TIMES TO COMMERCIAL VEHICLES OF THE RATED CAPACITY OF ONE TON OR MORE, NOT ORIGINATING OR TERMINATING ON SAID STREETS:

54TH STREET, between Collwood Boulevard and Montezuma Road;

BAJA DRIVE, between 54th Street and Campanile Drive; and

CAMPANILE DRIVE, between Baja Drive and Montezuma Road.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be, and they are hereby authorized to be made on said streets; and

BE IT FURTHER RESOLVED, that the regulations hereinabove imposed shall become effective upon the installation of such signs; and

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to take appropriate action to ensure that vehicular speed controls are observed in the areas previously designated.
