WHEREAS, California Government Code, Section 65869, provides that mandatory elements of the General Plan may not be amended more than three times per year; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider amendments to the "San Ysidro Community Plan"; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved, as submitted, amendments Nos. 1, 2 and 3, and modified and approved amendments Nos. 4, 8 and 9, and by unanimous vote, eight members present, filed amendments Nos. 5, 6 7, 10 and 11; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
