

RESOLUTION NO. 214068

**AUG 21 1975**

WHEREAS, the Public Services and Safety Committee conducted hearings on the concept of a paramedic program (herein called "program") within the City of San Diego; and

WHEREAS, said Committee determined after several public hearing sessions that the program should be instituted in the City and that the opportunity to vote on a tax override for the financing of the program should be placed before the voters; and

WHEREAS, in reaching its determination, the Committee concluded that the program should be operated by the San Diego Fire Department; and

WHEREAS, the Committee desires the Council to declare its intent to establish the program in the San Diego Fire Department in the event the tax override proposition is passed by the voters of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that should the paramedic program tax proposition be passed by the voters of the City of San Diego at the municipal election in November, 1975, it is the intention of the Council that such program be located in and operated by the San Diego Fire Department.

BE IT FURTHER RESOLVED, that should the paramedic program tax proposition be passed as above stated, the City Manager be and he is hereby directed to cooperate and work with private


